## TARIFF CNWY 199-AH.2

*Effective April 17, 2023*



Description	Amount
<b>Lineal Foot Application</b> (Item 234) XLF A lineal foot charge shall apply when a shipment, or combined portions thereof, meets all conditions of one of the following criteria:	
<b>Criteria #1:</b>	
• Equals or exceeds fourteen (14) feet of the length of trailer, and	
• Equals or exceeds forty-nine (49) inches of the width of trailer, and	
• Equals or exceeds fifty-one (51) inches of the height of trailer.	
<b>Criteria #2:</b>	
• Equals or exceeds one hundred twelve (112) square feet of the floor space of trailer: and	
• Equals or exceeds fifty-one (51) inches of the height of trailer.	
Charges shall be computed by applying the following rate per mile:	
Less than 750	\$0.20 cents per lineal foot
750 but less than 1200	\$0.18 cents per lineal foot
1200 but less than 1800	\$0.14 cents per lineal foot
1800 or greater	\$0.12 cents per lineal foot
Subject to a minimum charge of \$724.75	
<b>Lumper Service Fee</b> (Item 242) (LSO, LSD)	In addition to a \$10 .50 processing fee, Carrier will be reimbursed by Shipper for any and all lumper charges incurred
<b>Notification Prior to Delivery</b> (Item 221) (DNC)	\$14.75/Notification
