

Norbert Dentressangle SA First 9 months 2015 revenues

Lyon (France), 05 November 2015 – Norbert Dentressangle SA's consolidated revenues for the first 9 months of 2015 amounted to €4,026 million, up 19.3% compared to the same period in 2014.

Norbert Dentressangle SA expects a solid operating profit (EBITDA) for full year before non-recurring expenses relating to the change of control and the integration within the XPO Logistics Group.
